UK Pension Transfer Process

- 1) Complete a transfer Data Collection Form.

- 3) Move My Pension will then explain your options and fees to transfer the Pension to allow you to make an informed decision.
- 4) The Transfer documents and New Zealand Superannuation scheme's application form are completed and sent to the UK Pension scheme requesting a Transfer.
- 5) When all the requirements are met, your Pension is sent directly to the New Zealand Scheme to be invested as you have requested.
- 6) Transferring Pensions can take up to 6 months to complete depending upon the UK Pension schemes requirements.
- 7] Move My Pension can assist you further with Ongoing Monitoring of your Pensions and Retirement advice if required.
